### Hazel Avenue Improvement Project Temporary Closure of Nimbus Fish Hatchery Parking Lot & Entrance Road Monday, November 29 (8 a.m.) to Friday, December 17 (5 p.m.)

**When/Where:** Starting Monday, November 29 at 8 a.m., the Nimbus Fish Hatchery Parking Lot and Entrance Road will be closed for repaving. Information about the closure is as follows:

- **Parking Lot:** The Nimbus Fish Hatchery Parking Lot will be closed during repaving work. To accommodate visitors that use the parking lot, the California Department of Fish & Game has opened up an auxiliary lot that is located just west of the existing parking lot. Hatchery visitors should follow posted signs for auxiliary parking lot information.
- **Bike Paths:** The entrance to the hatchery will be closed, including the section of bike path that runs along the entrance road. This closure requires a minor modification to current bike paths. Bicyclists will be detoured to the American River Bike Trail just west of the hatchery entrance. Access will continue to be provided across Hazel Avenue at the Gold Country Boulevard intersection. **Bridge Construction:** The parking lot and entry road repaving work is part of the Hazel Avenue Improvement Project, which will widen the roadway from 4 to 6 lanes.

**Closure Period:** Sacramento County understands the challenges and inconvenience that bicyclists and pedestrians will experience during the parking lot closure period and ask for the public's patience and cooperation as we work to complete this project.
