## DA Swears-In Legal Research Assistants



District Attorney Jan Scully announced the swearing-in of nine legal research assistants (LRAs), all of whom chose to work for the office without promise of pay or employment.

After two years of budget cuts, the District Attorney's Office lost 20% of its general fund attorney positions. County funds for attorneys to prosecute homicides, gang cases, sexual assaults, robberies, burglaries, and many other crimes, including misdemeanors, have decreased.

In August 2010, Charles Bruce, Alice Cheng, Megan Eixenberger, TeriAnn Grimes, Lori Grogan, Stephanie Maroun, Mauro Quintero, Robert Romero and Alan Serrano became the first group of volunteer post Bar LRAs. They each worked without certainty of employment and without pay from August until November, which is when they started getting paid. A majority of them also worked for the office as volunteer interns for a year or longer while in law school.

As volunteer LRAs, they were assigned to various positions and units conducting in-court arraignments, pretrial negotiations and calendar duties, as well as research and writing assignments to assist deputy district attorneys. Their assistance helped to fill attorney resource gaps throughout the office, especially in the misdemeanor unit which has been the most impacted by budget cuts. Sworn in as deputies, but classified as LRAs, they now prosecute cases in the misdemeanor unit.

DA Jan Scully states, "The dedication shown by these individuals is a testament to their unwavering commitment to serve the Sacramento community and seek justice. I commend them for their service to our office and contribution to public safety in budget critical times."
